APA Report

- -- At the urging of the APA, the TSA clarified March 30 that inter modal carriers are exempt from Chain of Custody rules under the new Rail Security Regulations, thus paving the way for BNSF to lift the embargo on transporting 1.3G Fireworks.
- -- PHMSA recently approved an APA request to reclassify existing stocks of 1.3G fireworks devices of larger aerial shells and salutes to 1.1G devices. DOT procedure for obtaining this relief may be found on the member's only portion of the APA website.
- -- The Transportation Security Administration (TSA) is offering free Security Action Item (SAI) training workshops for motor carriers June-Sept. See http://www.tsa-sait.org/ for details.
- -- Under provisions of the economic stimulus package, small businesses with deductions exceeding their income in 2008 can use a new net operating loss provision to get a refund of taxes paid in prior years. See http://www.irs.gov/pub/irs-drop/rp-09-19.pdf for IRS guidance.
